CUSTOMER BONUS

TWO AND FREE

CUSTOMER REFERRAL BONUS: A CUSTOMER HAS UNTIL THE MATCHING CALENDAR DATE OF THE FOLLOWING MONTH, AFTER A SUBSCRIPTION HAS BEEN PAID, TO PERSONALLY REFER (2) PLATINUM PACKAGE CUSTOMERS, WHEN 2 ACTIVE PERSONAL REFERRALS

(NEW AND/OR EXISTING) HAVE BEEN MADE FOR THAT MONTH THAT CUSTOMER WILL HAVE THEIR MONTHLY FEE WAIVED FOR THE UPCOMING SUBSCRIPTION.

EX: IF A CUSTOMER PAYS AUGUST 15TH, THEY WILL HAVE UNTIL SEPTEMBER 15TH TO GET TWO ACTIVE CUSTOMER REFERRALS AND AT THAT POINT SEPTEMBER 15TH PAYMENT IS WAIVED.

FAST START/TEAM BUILDER BONUS (IBO ONLY)

\$10 ON LEVEL 2 (PLAT 600+)

\$5 ON LEVEL 3 (PLAT 1000+)

ON PERSONAL REFERRALS

LINE MAX RULE: WHEN ACHIEVING RANK, NO MORE THAN 40% OF THE REQUIRED GROUP VOLUME FROM ANY SINGLE UNI-LEVEL LEG MAY COUNT TOWARDS YOUR RANK.

CUSTOMER (55/45) RULE: WHEN ACHIEVING RANK, A MINIMUM OF 55% OF THE GROUP VOLUME MUST COME FROM RETAIL CUSTOMERS IN EACH UNILEVEL LEG. THIS MEANS THAT EACH LEG IN YOUR UNILEVEL MUST CONTAIN 55% ACTIVE RETAIL CUSTOMERS IF YOU WANT TO COUNT 100% OF THE VOLUME FOR THAT LEG. IF CUSTOMER VOLUME IS LESS THAN 55% OF TOTAL, THE SYSTEM WILL AUTOMATICALLY QUALIFY THE VOLUME THAT EQUATES TO MEET 55/45 RULE.

PRSV REQUIREMENTS: AT EACH RANK A CERTAIN AMOUNT OF PRSV IS REQUIRED (PERSONAL RETAIL SALES VOLUME). SEE COMPENSATION PLAN PDF FOR FURTHER DETAILS.
